 - Distribute the residuary estate.

How long will it take?

Typically, estate administration takes between six to nine months to obtain Grant of Probate, due to covid and delays.

However, the entire probate process can vary in length of time taken to be completed depending on the circumstances surrounding the estate.

If the estate involves complexities, the distribution of assets may take slightly longer.

If the instructions in the Will have led to a dispute between beneficiaries or relatives, this will also slow the process and will need to be resolved before any assets can be distributed.
